APPENDIX 3B – ISSUE OF SHARES TO CONVERTIBLE NOTE HOLDERS

As previously announced, the Company has elected to pay the interest instalment (equal to 3 cents per note) on the Company's 151.736 million listed convertible notes by the issue of shares.

As a result, 4,818,911 Resolute Mining ordinary shares have been issued today to convertible note holders registered on the record date. In accordance with the terms and conditions of the convertible notes, the shares have been issued at a price of \$0.9421 each.

In addition, 3,665 shares have been issued as a result of some listed option holders exercising their options to acquire Resolute ordinary shares at an issue price of \$0.60 each.
